

CONSULTATION ADMISSIONS POLICY FOR NURSERY SCHOOLS & CLASSES FOR 2024 - 2025

Introduction

This document outlines the process and policy as it applies to all Cambridgeshire County Council maintained nursery schools and classes.

See appendix 1 and 2 for a list of maintained nursery schools and nursery classes.

This policy is reviewed and consulted on annually to ensure it continues to reflect statutory and local changes in maintained nursery education legislation and guidance.

Compulsory school age

Compulsory school age is set out in section 8 of the Education Act 1996 and the Education (Start of Compulsory School Age) Order 1998 (SI 1998/1607). A child reaches compulsory school age on the prescribed day following their fifth birthday (or on their fifth birthday if it falls on a prescribed day). The prescribed days are 31 March, 31 August and 31 December.

NB: The current School Admissions Code 2021, which relates only to statutory education, does not apply to this policy.

Children are entitled to a full-time place in Reception in the September following their fourth birthday. Places offered under this admissions policy will be available to the child from the date the place is offered until 31st August following the child's fourth birthday. Parents should be made aware that the process for applying for a place at a Primary School for the Reception Year is separate to that of applying for a place in a Nursery Class or School.

Eligibility for Universal Early Education Funding for two-, three- and four-year-olds

Three-year-olds (and two-year-olds who meet the eligibility criteria) are entitled to 15 hours per week over no fewer than 38 weeks of the year (or 570 hours per year) of funded early years provision from the start of the term beginning on or following the date set out below:

- Children born in the period 1 January to 31 March: 1 April following the child's third birthday, or second birthday, as applicable.
- Children born in the period 1 April to 31 August: 1 September following the child's third birthday, or second birthday, as applicable.
- Children born in the period 1 September to 31 December: 1 January following the child's third birthday, or second birthday, as applicable.

These dates are consistent with those used for determining the start of compulsory education.

30 Hours Extended Childcare Entitlement

Families meeting certain eligibility criteria are entitled to a funded early years place of 30 hours per week over no fewer than 38 weeks of the year (or 1.140 hours per year).

In most cases, it is in the best interests of the child to take up their funded entitlement with one provider, however there may be reasons why this is not possible. In such circumstances it is possible to divide the entitlement across up to two providers in one day.

Once a place has been allocated to a child, and the child has started with that provider, any request to transfer to an alternative nursery class, school or early years provider will not be encouraged, unless there are valid, exceptional reasons for the transfer, e.g. house move.

Application Process for a Nursery Class or School Place

Parents may register their interest in a place at a nursery class or school at any time, but must formally apply for a place, using the Council's Parent/Carer Declaration Form. Information and application forms are available from each school, via their website or from the school office or, alternatively, from the County Council website.

Application Timetable

Applications will be processed, and letters to families informing them of the outcome of their request for placement for their child/ren will be issued no later than:

Catchment Area

The catchment area for a nursery class is the same as the published catchment area for admission to that school.

Each nursery school has its own catchment area. Details are available directly from the school.

Admission Number

Each nursery school, or class, has an admissions limit, determined locally. A nursery will be full and thus a child will be refused admission if the admissions limit has been reached.

Where there are places remaining, further admissions will be possible up to the agreed admission limit. However, places cannot be reserved for children who may move into the area later in the year.

Where more applications are received than places are available at a nursery school or class, places will be allocated in accordance with the published oversubscription criteria.

Where a tie-break is necessary within a category, priority will be given firstly to children who have a sibling attending the school at the time of admission and **then by date of birth with older children having priority**¹.

¹ If a further tie-break is needed, priority will be given to those living nearest the school, as measured by a straight line.

Waiting Lists

Children who are not offered places will have their details added to a waiting list. Children's names are placed on waiting lists in strict order of the oversubscription criteria, not according to the date of application. This list will be held until such time as the child is of statutory school age and expected to transfer to a Reception class.

If a place becomes available, the school will contact the parents of the child whose name is first on the waiting list.

Definitions

Siblings: Children living together in the same family unit, who have a sibling on the roll of the school at the time of application and admission to the school. Sibling includes:

- · brother, or sister;
- half-brother, or sister;
- adopted brother, or sister;
- child of the parent/carer or their partner;
- children looked after, or previously looked after. This doesn't include children temporarily living in the same household - for example a child in short-term, or interim, foster placement.

In every case, the sibling must be living permanently in the same family home (at least Monday to Friday) and must be on the roll of the school or have been offered and accepted a place at the school at the time of application and when the child starts.

Unless otherwise stated, in the case of the admission of children to a nursery class, children who are attending the primary school are **not** considered as siblings in terms of determining priority for places.

Home Address

The address given on a child's application should be the child's permanent or main residence at the time school places are allocated. This should also be the address where the child will be residing when they take up their place. A child's application can only be considered from **one** home address. Therefore, their "main residence" must be the address at which they spend the majority of their school nights (Sunday – Thursday). An address used for before and after-school childcare arrangements will **not** be considered appropriate.

For the purpose of determining admissions, distance within Cambridgeshire is calculated by measuring a straight line from the reference point of the home, as determined by the OS AddressBase Premium ™, to the reference point of the school.

Evidence

a) All Entitlements

Parents are required to provide proof of the child's date of birth and home address. Evidence may be submitted in the form of the child's short form birth certificate, passport, a child benefit letter or a utility bill (showing the parent's name).

Where a family is expecting to move house, confirmation of the new address will be required before the application can be considered. Confirmation should be by way of a copy of the signed lease agreement or a letter confirming contracts have been exchanged and with confirmation of a completion date.

b) 30 Hours Extended Childcare Entitlement only

There is no legislative requirement for a school to offer working parents the extended entitlement to free early learning and childcare. Each school will determine whether it will offer the 30 hour extended entitlement and the way in which this offer is delivered at the school. This will be a decision for the governing body of the school and will be published on the school's website.

Where the 30 hours extended entitlement is available, parents will be required to provide proof of their eligibility to the extended entitlement. This proof will be through the production of the unique code issued to the parent/carer by HMRC. The school is then required to carry out validation checks to confirm that the child is still entitled to an extended place before making offers to parents.

Absences

Short absences

Where a child is registered to attend the school but is unexpectedly absent for a single session or short period, no action is necessary.

Extended absences

Where extended absence occurs for medical reasons, the school will work to support the family in the most appropriate way for the individual child. It may be that keeping a place open may smooth the way for a phased return and be the best approach for the needs of the child concerned.

Extended absences for other reasons must be discussed in advance with the school. Parents are encouraged to take family holidays/vacations during the school holidays, but if this is not possible, the request must be made in writing to the school including details of the dates of the proposed absence and the reasons for the request.

The school will respond in writing to the request. Parents are advised that any request/absence for more than 4 weeks may result in their child's place at the school being withdrawn and offered to another family.

Withdrawing Offers of Nursery Places

Change in Circumstances

Parents are obliged to inform the nursery school or class of any change of address following an application, as this may affect the allocation of a place. Failure to do this could result in an offered place being withdrawn.

Once a place has been offered in writing, there are limited circumstances in which the nursery school or class can consider withdrawing the offer. If a place is offered on the basis of a fraudulent or intentionally misleading application, or a parent has not responded to an offer

within 10 school days, the school may withdraw the place. These serious situations can only be considered with the full involvement and agreement of the Early Years Funding Team.

30 Hours Extended Childcare Entitlement – when a parent ceases to meet the eligibility criteria for a funded place under the 30 hours extended entitlement, their child's place will continue to be funded during a "grace period". At the end of the grace period, if the parent's eligibility can no longer be confirmed, the parent will be able to access 15 hours universal funded early education and childcare at the school, but additional hours would be agreed through a separate private arrangement between the parent and the school and would no longer be funded.

The Council is required by government to ensure that no child is in receipt of more than their entitlement of early education and childcare funding.

Charging for Places

With effect from September 2012, regulations came into force which allow schools to charge for spare places in maintained nursery classes and nursery schools. Details of where this is available to parents, and a copy of the relevant Charging Policy, will be available from the school.

Admission of Children to the Reception Year at School

A child is entitled to a full-time place at school in the September following their fourth birthday. The child's parents can defer the date their child is admitted to school until later in the school year, but not beyond the point at which they reach compulsory school age and not beyond the beginning of the final term of the school year for which the offer was made. Where the parents wish, the child may attend part-time until later in the school year, but not beyond the point at which they reach compulsory school age.

Please note: four-year olds in Primary School Reception classes are **not** eligible for early years funding. From the date a parent accepts a school place and agrees a start date, even if the choice is for them to attend on a part-time basis, the free early years entitlement will no longer be available.

Parents who would like their child to continue in the nursery school or nursery class beyond this date, i.e. parents of children who are eligible to start Reception at school from the beginning of the Autumn Term and are opting to delay this start, **must** make a fresh application for a place at the nursery school or nursery class for the new academic year, although the place is not guaranteed.

Those children with an Education, Health and Care Plan that does not name the school will be referred to Statutory Assessment and Resource Team to determine an appropriate place.

- 1. Care Experienced children previously known as Looked After Children (LAC), and children who were looked after but ceased to be so by reason of adoption, a resident order or special guardianship order:
- 2. Children who have been referred by a Social Worker, Health professional, Pre-School Specialist Support Teacher, Special Needs Officer, the Traveller Referral Team
- 3. Children with a sibling in the two year old provision (The Nest) or Nursery
- 4. Children of contracted members of staff and governors of the Homerton Early Years Centre
- 5. Children living in the catchment area of the school;

Over-subscription criteria – Three and Four Year Olds:

Where more applications for 3 and 4 year olds are received than places are available, places will be allocated in accordance with the following over-subscription criteria:

Children who have an Education, Health and Care Plan that names the school will be admitted before the over-subscription criteria are applied. Those children with an Education, Health and Care Plan that does not name the school will be referred to Statutory Assessment and Resource Team to determine an appropriate place.

- Care Experienced children previously known as Looked After Children (LAC), and children who
 were looked after but ceased to be so by reason of adoption, a resident order or special
 guardianship order;
- 2. Children who have been referred by a Social Worker, Health professional, Pre-School Specialist Support Teacher, Special Needs Officer, the Traveller Referral Team or have previously attended the school under the two year old funded entitlement
- 3. Children who have previously attended the two year old provision who will be eligible to move into the Nursery at the start of the academic year in September.
- 4. Children of a contracted member of staff and governors of the Homerton Early Years Centre
- 5. Children living in the catchment area who have who have not yet reached statutory school age before the term of admission
